I Thomas Tracy Mariner belonging to his Majesty's Ship = Pearl Captain Thomas Wilkinson Commander being in Bodily = Health and of sound and disposing Mind and Memory and considering the dangers of the Seas and other Uncertainties of this Transitory life, do (for avoiding Controversies after my decease) make publish and Declare this my last Will and Testament in manner following, that is to say, first I = recommend my Soul to God that gave it and my Body I commit to the Earth or Sea as it shall please God to Order and as for all my worldly Estate I give bequeath and dispose thereof as followeth that is to say unto = William Tracy my Son of the parish of White Chapel = Rosemary Lane London all Wages Sum and Sums of = Money Lands Tenements Goods Chattels and Estate whatsoever as shall be any ways due owing or belonging unto me = at the time of my decease I give devise and bequeath the same unto my said Son and I do hereby nominate and appoint my foresaid Son William Tracy sole Executor of this my last Will and Testament hereby revoking all former and other Wills Testaments and Deeds of Gift by me at = any time heretofore made and I do ordain ^{and ratify} these presents to stand and be for my only last Will and Testament In witness whereof to this my said Will I have set my hand and Seal the fifth day of March ^{and} in the sixteenth = Year of the Reign of Our Sovereign Lord King George the Third over Great Britain France and Ireland Defender of the Faith and so forth and in the Year of Our Lord one = thousand seven hundred and seventy six Thom^o. Tracy ^{SS} = signed Sealed and published in the presence of us John Stephen, Jo^o. Staple, Hen. Griddle.

and seventy nine first my Will is that all my just debts
and funeral Expences shall be paid and discharged as soon
as conveniently may be And I give devise and bequeath
unto my Wife Elizabeth All my Household Estate at Shipley
in the said County of Salop now in the holding of Daniel
Banton To hold unto my said Wife and her Assigns
during her natural life she paying thereout the Interest
of the Sum of four hundred pounds wherewith the same is
Charged by Mortgage to Mr. Thomas Pass of Abridgworth
aforesaid Chiefe Factor and my Will is that the said Sum
of four hundred pounds shall continue a charge upon the
said Estate during the life of my said Wife and which
debt to her I do hereby Declare to be in lieu and
Satisfaction for the Bond or Engagement I entered into
previous to our Marriage for serving to her for her life
a annuity of twenty pounds a Year in case she survived
me And from and immediately after the Decease of my
said Wife I give and devise my said Estate at Shipley
unto the said Thomas Pass and Edward Thornes of Abthall
in the said County Gentleman and their Heirs Upon Trust
that they the said Thomas Pass and Edward Thornes or
the Survivor of them or the Heirs or Assigns of such a
Survivor do and shall sell and dispose of the said Estate
to the best purchaser or purchasers and for the most
Money that can be got for the same And upon further
Trust to pay and apply the Money arising by such a
Sale (after discharging the said Mortgage for four hundred
pounds and Interest as follows) that is to say to the
said Thomas Pass and Sarah his Wife the Sum of four
hundred pounds to be paid and applied to and for the
use of their Daughters in such manner as they or the
Survivor of them shall by Deed or Will direct and in
default thereof to be equally divided between them to
Mr. John Marston of Birmingham Brass Founder and Ann
his Wife the like Sum of four hundred pounds to be paid
and applied to and for the use of their Daughters in
